Hazards to Humans and Domestic Animals

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

READ THIS LABEL: Read this entire label and follow all use directions and use precautions.

IMPORTANT: Do not expose children, pets or other non-target animals to rodenticides. To help prevent accidents:

1. Store product not in use in a location out of reach of children and pets.
2. Apply bait in locations out of reach of children, pets, domestic animals and non-target wildlife, OR in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hooved livestock, raccoons, bears, other potentially destructive animals or in areas prone to vandalism.
3. Dispose of product container, unused, spoiled and unconsumed bait as specified on this label.

USE RESTRICTIONS: This product may be used to control Voles, Norway Rats, Roof Rats and House Mice. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come into contact with food. If applied for voles in secured, tamper-resistant bait stations, this product may also be used in parks, woodlots, yards and lots surrounding residential buildings, and non-crop areas near agricultural buildings. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in contact with food. Do not use this product within the occupied habitats of threatened or endangered *Peromyscus* spp. mice.

URBAN AREAS: This product may be used in and around homes, and industrial, commercial and public buildings. This product may also be used in transport vehicles (ships, trains, aircraft) and in and around related port or terminal buildings. Applications "around" buildings must be made in tamper-resistant bait stations placed along walls or other external parts of buildings (e.g. doorways, ramps, loading docks) where voles, rats or mice might seek to gain entrance.

NON-URBAN AREAS: In non-urban areas, this product may be used only in and around homes and agricultural buildings for voles, rats and mice. If applied in secured, tamper-resistant bait stations, this product may also be used in parks, woodlots, yards and lots surrounding residential buildings, and non-crop areas near agricultural buildings.

SELECTION OF TREATMENT AREAS: Determine areas where voles, rats or mice will most likely find and consume bait. Generally, these are along walls, by gnawed openings, in corners and concealed places, between floors or walls, or in locations where rodents or their signs have been seen. Remove as much alternative food as possible. For voles, look for runways in lawns, flowerbeds or near shrubs and bushes.

APPLICATION DIRECTIONS

Voles: Place 2-4 placepacks in tamper-resistant bait stations or in areas protected from children, pets and wildlife. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of vole activity cease.

Rats: Place at least 2-8 packs per placement. Space placements at 15-30 foot intervals. Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease.

Mice: Place one pack per placement. Space placements at 8-12 foot intervals. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.

Rats and Mice: Immediately replace contaminated or spoiled bait. Properly collect and dispose of all visible dead animals and leftover bait. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation occurs, repeat treatment. For a continuous infestation, set up permanent bait stations and replenish bait as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in original container in a cool, dry place inaccessible to children and pets.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Triple rinse (or equivalent) then offer for recycling or reconditioning; or puncture and dispose of in a sanitary landfill; or incineration; or if allowed by state and local authorities, by burning; if burned, stay out of smoke.
