GENERAL INFORMATION

Monterey Manni-Plex Micro is a micronutrient solution for the prevention and correction of micronutrient deficiency when used as part of a balanced fertilizer program.

RATES:

Vegetables, Ornamentals, Vines and Greenhouse Crops: Apply 2 – 4 teaspoons per gallon of water per application throughout the growing season.


Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, general crop health and crop species. For best results, follow soil test or plant analysis recommendation.

MIXING AND HANDLING INSTRUCTIONS:

Put 1/3 to 2/3 of total required water volume in sprayer. Add adjuvants, fertilizers and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of this product and agitate until thoroughly mixed. Fill tank with remainder of water.

Check chemical mixture compatibility using a jar test prior to application. Be cautious when mixing with phosphate solutions
