Monterey Nutrient Solution Step 2 is designed for use with Monterey Nutrient Solution Step 1. When used together, Step 1 and Step 2 become a multi-nutrient package enhanced with Calcium for all types of plants in all growing mediums. These nutrient packages can be used at all stages of growth.

Application Rate Chart – Add recommended amount of Monterey Nutrient Solutions Step 1 and Step 2 into 1 gallon of water.

8 Week Hydroponic or Soil – Daily Application

	Grow Week 1	Grow Weeks 2-4
Step 1 and Step 2	3 mL	6 mL

	Bloom Week 1	Bloom Weeks 2-8	Bloom Week 9
Step 1 and Step 2	6 mL	8 mL	Flush

For Weekly Application:

Use 38 mL each of Solutions Step 1 and Step 2 in 1 gallon of water on Day 1; then apply only water for the remaining 6 days.

Metric to US Conversion:

5 mL = 1 Teaspoon; 15 mL = 1 Tablespoon; 30 mL = 1 Fluid Ounce; 946 mL = 1 Quart; 3.79 L = 1 US Gallon
