As a soil application to annual crops, a lesser response from initial crop, with a corresponding superior response from succeeding crops, may be observed. In addition, placement close to seeds or roots zones may be injurious to crops. The effect may be aggravated by a soil pH below 6.5.

General Information:

Monterey Pro-Bloom is useful to prevent or correct nutrient deficiencies. Phosphate and potassium are particularly useful to encourage blooming of ornamentals.

APPLICATION RATES	
ONCE A MONTH	2 Tbs. Per 1 Gallon of Water
TWICE A MONTH	1 Tbs. Per 1 Gallon of Water
EACH WATERING	1 Tsp. Per 1 Gallon of Water

Can be applied in a water bucket, pump-up or hose-end sprayer.

Soil Application: See the chart above to determine application rates. Thoroughly soak soil around plant's root zone with dilution.

Foliar Application: See the chart above to determine application rates. Do not apply as a foliar application in drought conditions.

Apply foliar applications early in the morning or late evening. Do not water for at least 24 hours to avoid washing off fertilizer. This allows uptake of nutrients into the leaf.

ATTENTION: This product contains phosphites and may be phytotoxic to plants. Phosphite is not a source of plant available phosphorus. Do not use if the plants or soil/growing media is deficient in plant available phosphate. Based on soil/growing media conditions, and nutrient requirements of the plant(s), the use or misuse of phosphites may trigger a phosphate starvation response (restrict a plant's uptake of phosphate).

ATTENTION: This product contains boron; use on any crops other than those recommended may result in serious injury to the crops. The application of fertilizing materials containing molybdenum (Mo) may result in forage crops containing levels of molybdenum (Mo) which are toxic to ruminant animals.

NOTE: Adding more than the recommended rate may burn plants. Do not use spraying devices that have been used with herbicides unless thoroughly cleaned.

IMPORTANT NOTICE: This product may stain. Keep spray off areas such as: sidewalks, patios, driveways, fences, and painted areas. As a precaution, rinse off these areas with water after applying.
