GENERAL RECOMMENDATIONS

Monterey Humic Acid 12 may be applied to most plants and may enhance micronutrient uptake. This product is readily dispersed in most fertilizer or micronutrient products. Always apply Monterey Humic Acid 12 right from the start, at planting, transplant or at first flush in the spring.

TRANSPLANT ROOT DIP

Before transplanting, dip seedling roots for a few minutes in a solution of 3 Fl. Oz. in 1 gallon of water.

FOLIAR APPLICATION

For all vegetable crops, ornamentals, strawberries, and greenhouse crops, etc.: Apply at the rate of 3 Fl. Oz. per 1 gallon of water. Apply throughout the growing season.

POTTING SOILS


Add 1 quart Monterey Humic Acid 12 per 50 pounds of potting mix.

MIXING INSTRUCTIONS

Put 1/3 of water in sprayer tank. Add correct amount of Monterey Humic Acid 12 to water first while agitating. Add other products at their appropriate rate. Fill sprayer with balance of water to desired volume. Agitate adequately to mix.

NOTE: Monterey Humic Acid 12 is not compatible with oil based sprays or very low pH material. As with all spray mixtures, always check product compatibilities with standard jar test prior to mixing.
